# 1. 前言

# 2. 產品概觀

本章介紹 QNAP TS-x31P3 NAS 的基本資訊。

#### 關於 TS-x31P3

TS-x31P3 是簡單易用的 NAS 設備,專為家庭及辦公室環境所設計。此 NAS 設備具備充足儲存空間及檔案備份、分享功能,並搭載 Annapurna Labs Alpine AL-314 四核心 1.7 GHz 處理器及 DDR3L RAM。TS-x31P3 能夠更為順暢地播放多媒體內容並同時確保資料的安全性,同時具備各種當地、遠端及雲端備份選項。此款 NAS 提供 2 個硬碟插槽及 4 個硬碟插槽機型,支援 SATA 6 Gbps 並且與 SATA 3 Gbps 回溯相容。其具備 2.5 Gigabit 乙太網路連接埠、Gigabit 乙太網路連接埠和三個 USB 3.2 Gen 1 連接埠。

#### 8. Additional Terms.
